

Open admission: Admission policy under which virtually all secondary school graduates or students with GED equivalency Other expenses (costs): Include average costs for clothing, laundry, entertainment, medical (if not a required fee), and Out-of-state tuition: The tuition charged by institutions to those students who do not meet the institution's or state's residency Part-time student (undergraduate): A student enrolled for fewer than 12 credits per semester or quarter, or fewer than 24 Permanent Resident or other eligible non-citizen: A person who is not a citizen or national of the United States and who has \*Personal counseling: One-on-one or group counseling with trained professionals for students who want to explore personal, Post-baccalaureate certificate: An award that requires completion of an organized program of study requiring 18 credit hours Post-master's certificate: An award that requires completion of an organized program of study of 24 credit hours beyond the Postsecondary award, certificate, or diploma: Includes the following three IPEDS definitions for postsecondary awards, Less Than 1 Academic Year: Requires completion of an organized program of study at the postsecondary level (below the At Least 1 But Less Than 2 Academic Years: Requires completion of an organized program of study at the postsecondary level At Least 2 But Less Than 4 Academic Years: Requires completion of an organized program of study at the postsecondary level **Private institution:** An educational institution controlled by a private individual(s) or by a nongovernmental agency, usually Private for-profit institution: A private institution in which the individual(s) or agency in control receives compensation, other Private nonprofit institution: A private institution in which the individual(s) or agency in control receives no compensation, Proprietary institution: See Private for-profit institution.

Public institution: An educational institution whose programs and activities are operated by publicly elected or appointed Quarter calendar system: A calendar system in which the academic year consists of three sessions called quarters of about 12 Race/ethnicity: Category used to describe groups to which individuals belong, identify with, or belong in the eyes of the Race/ethnicity unknown: Category used to classify students or employees whose race/ethnicity is not known and whom Recognized Postsecondary Credential: Includes both Title IV eligible degrees, certificates, and other recognized postsecondary Religious affiliation/commitment (as admission factor): Special consideration given in the admission process for affiliation \*Religious counseling: One-on-one or group counseling with trained professionals for students who want to explore religious \*Developmental services: Instructional courses designed for students deficient in the general competencies necessary for a Required fees: Fixed sum charged to students for items not covered by tuition and required of such a large proportion of all Food and housing (charges)—on campus: Assume double occupancy in institutional housing and 19 meals per week (or Secondary school record (as admission factor): Information maintained by the secondary school that may include such things Semester calendar system: A calendar system that consists of two semesters during the academic year with about 16 weeks Student-designed major: A program of study based on individual interests, designed with the assistance of an adviser. Study abroad: Any arrangement by which a student completes part of the college program studying in another country. Can be \*Summer session: A summer session is shorter than a regular semester and not considered part of the academic year. \*Tutoring: May range from one-on-one tutoring in specific subjects to tutoring in an area such as math, reading, or writing.
Unit: a standard of measurement representing hours of academic instruction (e.g., semester credit, quarter credit, clock hour).
Undergraduate: A student enrolled in a four- or five-year bachelor's degree program, an associate degree program, or a
Undergraduate Research: Opportunities offered to undergraduate students to make original contributions in an academic
\*Veteran's counseling: Helps veterans and their dependents obtain benefits for their selected program and provides
\*Visually impaired: Any person whose sight loss is not correctable and is sufficiently severe as to adversely affect educational
Volunteer work (as admission factor): Special consideration given to students for activity done on a volunteer basis (e.g.,
Wait list: List of students who meet the admission requirements but will only be offered a place in the class if space becomes
Weekend college: A program that allows students to take a complete course of study and attend classes only on weekends.
White: A person having origins in any of the original peoples of Europe, the Middle East, or North Africa.

\*Women's center: Center with programs, academic activities, and/or services intended to promote an understanding of the Work experience (as admission factor): Special consideration given to students who have been employed prior to application,
